#### **COVID-19 Safety Protocol**

#### Access to the venue:

- Safety, cleaning, and disinfection protocols:
  - Temperature taking
  - o Hand sanitiser dispensers
  - o Face masks must be worn
  - o Methacrylate screens for separation in reception areas
  - Extra cleaning service
- Safety distance:
  - Planning the access and movement of those attending
  - We will implement queue management and crowd control mechanisms with floor markings, signage, and the support of auxiliary personnel

#### Inside the venue:

- Face masks must be worn
- Hand sanitiser dispensers distributed throughout the venue
- Safety distance
  - o Planning the access and movement of those attending
  - We will implement queue management and crowd control mechanisms with floor markings, signage, and the support of auxiliary personnel
  - Itineraries will be established to direct the movement of those attending in the various areas of the venue, in particular the exhibition area.
- Reduction of capacity: the capacity will be established according to current regulations. Signs and control in the various spaces (the exhibition area, common areas, the assembly room)
- Encouraging a non contact policy
- Cleaning and disinfection protocols for those attending the Congress and for exhibitors. Extra cleaning service (waste elimination control). Desinfection of spaces.
- Those attending and the exhibitors will have access to sufficient wastepaper bins with lids and pedals for discarding high-risk material such as face masks, tissues, disposable beakers, etc.
- The installations will be ventilated regularly
- Catering: this will be organised in accordance with sanitary measures
- Service staff provided with Personal Protective Equipment (PPE)



#### Sanitary measures:

- Protocol for action if an infected person is detected
- Isolation room
- Notifying the health authorities

#### Complying with the measures:

- Suppliers must sign an affidavit of compliance with the measures established and based on the regulations current when the congress is held.
- Registration and payment of the fee by those attending the Congress implies that they will accept the measures established, which will be notified together with confirmation of registration and will be updated days before their attendance, adapting the measures to current regulations.
- Signing of the contract by the exhibitors implies their knowledge and acceptance of the measures stated.

Note: No data of any kind will be kept on the temperature of anyone or his/her situation if the maximum temperature permitted is exceeded. Data will only serve to obtain the traceability of those attending in the event of infection and so as to send the information to the public health authorities.
